Board of Directors and Manager's Report for 2008

Administration

Total pulse acreage in 2008 was approximately 560,000 acres, up substantially compared to 2007's 494,000 acres. Most of the acreage increase came from a large jump in soybean acres which topped 310,000 in 2008. The growing season was variable depending on location with the main pea growing region in the southwest experiencing drought early in the year, the Interlake and southeast receiving heavy rainfall throughout the year, and the Red River Valley seeing a combination of both depending on location. Harvest conditions were also variable, with the season drawn out in particular for soybean growers in northern areas. Depending on crop type, yields were average to slightly below. Levy revenue totaled \$883,000 in 2008, a reflection of improved prices for pulses of all types. 53 producers requested a levy refund representing just 4.9% of total levy collected. MPGA has maintained its research and other commitments in 2008, and has budgeted for a balanced budget in 2009. Manitoba Corn Growers Association continued to administer the pulse cash advance program on behalf of MPGA. In general, Cash Advance Program participation remains strong, and MPGA continues to be involved to provide value to producers.

The Board of Directors met 6 times in 2008, in addition to several committee meetings. Directors also attended a significant number of provincial, national and international meetings and conferences. In 2008, MPGA continued its partnership with the National Sunflower Association of Canada (NSAC), the Manitoba Corn Growers Association (MCGA), and Manitoba Agriculture, Food and Rural Initiatives (MAFRI) and helped organize the second Manitoba Special Crops Symposium. The event was held at the MacDon Exhibition Center in Winnipeg. MPGA extended this partnership with NSAC and MCGA by helping to organize the first Manitoba Special Crops Summer Tour which took place July 23rd at the AAFC Morden Research Station, Hyland Research Farm near Carman, and the U of M Carman Campus. The joint tour allowed growers of pulses, sunflowers, and corn to take in one tour instead of multiple tours. Attendance was very good, and it's expected another joint tour will take place in 2009. Other major events MPGA organized and hosted included the annual Soybean Field Day and Tour July 10th at Kelburn Farm, just south of Winnipeg, and the annual Industry Meeting held November 25th where all facets of the pulse industry came together to discuss mutual issues. MPGA also helped organize the first Manitoba Special Crops Summit June 3rd where representatives from the province's smaller acreage crop organizations came together in Carman to discuss issues of mutual concern.

Research

MPGA allocated \$257,000 to research in 2008 maintaining funding to all pre-existing projects and addressing some additional national issues. Approximately 22 different projects were supported focusing on genetic improvement, pathology, agronomy and nutritional analysis research in edible beans, peas and soybeans. Many MPGA contributions are matched either by Matching Investment Initiative (MII), Agri-Food Research and Development Initiative (ARDI), or Covering New Ground (CNG) now known as the Agricultural Sustainability Initiative (ASI).

MPGA continued its commitment to the further development of the fababean industry by attending a meeting of the Faba Bean "Cropportunity" Strategy team in September. The team includes representation from Alberta and Saskatchewan pulse organizations, plus provincial agricultural departments. MPGA also continues to support fababean agronomic work conducted by MAFRI.

MPGA continues to collaborate with the Ontario Soybean Growers on research projects, and has been working with the Ontario Oil and Protein Seed Crop Committee with regards to recommendations for soybean variety registrations.

Promotions

MPGA continued to support Pulse Canada initiatives in 2008, as well as the Canadian Soybean Council. MPGA has been very supportive of a number of market development initiatives independently as well as in conjunction with activities coordinated by Pulse Canada. MPGA hosted a portion of the Canadian Soybean Council's 2008 incoming mission from Japan. Representatives from the country's largest soybean buyers toured a farm involved in non-GMO soybean production, as well as MPGA's Soybean variety trials near Carman.

MPGA's domestic market development efforts continued in 2008 with two appearances on the popular cooking show *Great Tastes of Manitoba*. MPGA also took part in the Canadian Diabetes Association's annual Livesmart Diabetes Expo which took place in Brandon. Demand for recipes and nutrition information continues to increase each year. In 2008 MPGA joined its provincial partners and Pulse Canada to develop a new cookbook/nutrition guide for pulses. *Pulses Cooking With Beans, Peas, Lentils and Chickpeas* will be available to consumers and health professionals this spring.

Communication

The *Pulse Beat* is published 3 times a year, and continues to be the main communication tool with members. The Variety Trial Evaluations are published in December of each year, and included in that month's edition of *Pulse Beat*. MPGA participates with Alberta Pulse Growers and Saskatchewan Pulse Growers in the distribution of the *Feed Pea Focus* newsletter aimed at increasing utilization of feed peas within livestock rations. MPGA's website www.manitobapulse.ca was totally redesigned in 2008, and now features even more information for members including previous issues of *Pulse Bea*t, Variety trial results, market reports, coming events, and much more.

Policy

MPGÅ continues to be active on numerous committees including the NAFTA Technical Working Group on Pesticide Harmonization, Pulse Canada, the Canadian Grain Commission's Western Standards committee and the Special Crops Subcommittee, Keystone Agricultural Producers.

Consultations with Manitoba Agricultural Services Corporation remain a very high priority as MPGA works to convey the concerns of producers by providing constructive suggestions. 2008 involved several important consultations including the push for an expansion of the crop insurance area for soybeans, and the methods used to adjust losses in edible beans after hail damage occurs.

MPGA also worked extensively with its provincial partners and Pulse Canada in 2008 to develop a new vision document for the industry as the basis for accessing funding under the Government of Canada's new agricultural policy framework *Growing Forward*.

Profile of the Manitoba Pulse Growers Association

MPGA represents approximately 3800 producers of peas, edible beans, soybeans, fababeans, chickpeas and lentils throughout Manitoba. MPGA is governed by a 14 member board, 10 elected active producers and 4 appointed directors representing Agriculture and Agri-Food Canada, Manitoba Agriculture, Food and Rural Initiatives, The Faculty of Agricultural and Food Sciences, University of Manitoba, and Manitoba Pulse Crop processing firms as nominated by the Canadian Special Crops Association. The office is located at 38 4th Avenue N.E. in Carman, Manitoba and is staffed by two full time employees.

Mission Statement

To provide its members with production and marketing support, through focused research, advocacy and linkages with industry partners.

Focus Statement

Improve members' profitability from pulses through:

- Broadened access to pulse markets.
- Giving leadership and focus to research and development.
- Representing Manitoba pulse producers in areas of government and industry policy affecting returns to pulse growers.

The Association is funded by a check-off of .5% of pulse crop sales. Close to 50% of the funds are used for research to improve varieties, disease control, and agronomy for Manitoba producers. As well, MPGA provides a voice to governments and their agencies in regards to changes in crop insurance, safety nets, grading and standards, licensing and security, and pesticide policies. The organization has a domestic promotion program to improve and increase the use of pulse crops both for human and animal consumption, and is intensely involved in the efforts of Pulse Canada to access new markets throughout the world.

Profile of Pulse Canada

Pulse Canada is a national industry association formed through the partnership between the pulse growers and the pulse trade in Canada. This organization represents provincial pulse grower groups from Alberta, Saskatchewan, Manitoba, Ontario and the pulse trade from across Canada that are members of the Canadian Special Crops Association (CSCA). The success of Pulse Canada has been in finding areas of common interest between member organizations, as well as with the Government of Canada, and finding the most efficient and effective way to address those interests on a national basis.

Pulse Canada operations can be categorized into several focus areas. Under Market Access, staff address critical tariff and non-tariff barriers in international markets. Within Transportation, Pulse Canada is working to bring the industry together to address shipping problems that confront the pulse sector and undermine profitability. Food and Feed Business Development initiatives are focused on expanding market opportunities for pulses in North America and in overseas markets. The attractive health, nutrition and environmental attributes of pulses are key opportunities to create new demand. In addition, staff conduct market intelligence work and promote Canadian pulse crops internationally by communicating with and visiting major customers around the world and attending key trade shows. Within the Environment profile, information is provided to producers on maximum residue limits for chemical inputs, work is carried out to harmonize regulations with trading partners (particularly cross border), and down the road, the focus on issues surrounding energy and sustainable production is poised to increase. Pulse Canada also acts as the industry voice on certain domestic policy matters.

Pulse Canada's head office is in Winnipeg, with Barry Grabo of the Alberta Pulse Growers Commission as Chair, Gordon Bacon - CEO, Greg Cherewyk - Director of Transportation, Jackie Tenuta and Carl Potts - Directors of Market Development, Mark Goodwin, - Pest Management Coordinator, Peter Watts - Director of Market Innovation, Chantal Dupasquier — (Acting) Manager of Market Innovation, Heather Maskus - Manager of Food Innovation, Nikki Donald - Food Product and Recipe Developer, Gord Kurbis - Director, Environment, Jeff Bond - Director, Feed Pea Network, Brian Gilchrist - Finance Manager, and Denise Medeiros - Office Manager.
